GBYSL Registration, Rosters and ID Cards

They will drop off the rosters at El Rancho Grande restaurant, Gardnerville. Coaches will need to pick up the rosters 2/25 – 3/1, glue the players/coaches photos on the ID cards and return the packet to El Rancho Grande. On 3/3 all the packets will be taken back to Great Basin Credit Union to be laminated. Check the ID cards against the roster and against the players' birth certificates for birthday errors.
