Call to order at 7:40 p.m. by Tim Dry.

Treasurer's Report

Rich Nalder was not present at tonight's meeting. Tim reports that all checks have been deposited. Rich should have the team balances at next month's meeting.

GBYSL Report

The Mackenzie Burgees Fund is a scholarship fund set up in memory of this young soccer player who passed away. GBYSL will use these funds to help players with financial needs. More info available on the GBYSL website.

Coaches must wear their coach's badge at all league games. A coach without a badge will not be allowed on the team's sideline. Referees will enforce this rule. Tim suggests coaches keep their badges with their team player cards.

Home Team responsibilities:

Supply game ball

Make sure all field equipment is set up prior to game. Put away all field equipment after the game.

Home team must change uniform, if there are similar uniform colors.

If one referee attends game, both teams provide an assistant referee for sidelines. If two referees attend game, the home team provides an assistant referee for sideline.

Coaches must take team player cards, copies of all the players medical release forms, and coach's badge to all games.

All GBYSL players can attend UNR girl's soccer games free. Players need a copy of their GBYSL player card to receive free entry.

GBYSL has ongoing coaches training. Information is available on the GBYSL website. Tim is trying to get some local training sessions in Carson or Carson Valley.

Team Reports

All fall teams are ready for the season.

If coaches experience any problems/issues at games or practices, please notify Tim to resolve the issue locally before taking the issue to the league.

Practice Schedules and Fields

Practice fields for fall are Pinion Hills Elementary School and Lampe Park, baseball outfield.

All other local soccer fields are in use by AYSO. Rene Hoogendijk has been using Westwood Park.

If coaches experience conflicts at Lampe Park, politely ask the other coach to share the space.

So far, the various team practice schedules are going well with enough space at the fields.

Pinion Hills Field Maintenance

The goals, nets, and lines are ready. The field is a little short (57 yds. by 90 yds.) but plays fine. Tim has already filled several holes on the field. Call Tim if you notice further repairs are needed. Each CVSC team will be assigned field maintenance once or twice during the fall season. On your assigned week, you will need to re-line the field and fix any problems with the net. The locker box has all the needed supplies. Tim will do first two weeks of the season. Jim Talia will do the second two weeks. Remaining weeks to be assigned by Tim.

CVSC Logo Design Contest

This contest is to develop a logo for the Carson Valley Soccer Club. Logo will be used for a patch to be put on all CVSC team uniform shirts, on CVSC letterhead, with CVSC publicity and fliers. Contest is open to all CVSC players. Tim will create a flier describing the contest rules and information. Fliers will be distributed to players by the coaches. Entries can be hand drawn or computer generated. The logo will be converted to a computer graphic for club use. The winning design will receive a prize. Suggested prize is a \$75 certificate for soccer.com. CVSC reserves the right to reject all entries.

Western Nevada College Girls Soccer team is encouraging teams to attend their games. Tim will look into setting up a CVSC Team day for all CVSC teams to attend.

Suggestions: expand this tournament with invitations to include teams from Carson City or Reno, expand the adult team portion of the tournament.
