GBYSL Report

GBYSL has had two meetings since the last CVSC meeting.

The High Sierra League (a recreation league) will fold at the end of spring 2008 season. GBYSL is combining their small recreation league with High Sierra. GBYSL Recreation League will increase from 3,000 kids to 4,500 kids. GBYSL will acquire High Sierra's equipment.

A Signature League is in development for the summer. It will consist of U11, U12, U13, U14 semi-elite teams from the different areas of GBYSL. Teams are mostly for training development purposes. Teams from different areas will play games against each other. Tryouts will be held. More information to come.

- Clean up the field after the game, throw out water bottles, trash from team sideline.
- If you are the last game of the day, please put away the flags. Flags are being left out and will be stolen.
